Farm staff will arrive approximately 1 hour before requested time for set-up of the Deluxe Petting Farm and 20-30 minutes' prior for set-up of the Mini Petting Farm. Visitors are not allowed in pen area during the set-up or breakdown process.

The traveling farm comes equipped with hay bales for seating & décor, pop-up shelter for shade or rain, hand sanitizer, pen(s), and an array of clean friendly farm animals. Farm staff provides a safe and inviting environment for visitors of all ages to enjoy.

**Mileage Fee:** \$1.50 per mile is calculated, one way, from farm address to event location address and added to total balance due. Animal assortment will vary seasonally. 1 hour minimum required for Mini Petting farm, and 2 hours required for Deluxe package.

*\*\*Like a human, animals need rest breaks too. Animals may be pulled aside for watering, etc., as needed, from time to time during long events\*\**

### TERMS AND CONDITIONS:

- The date and time requested is not reserved until a signed reservation agreement is received. A non-refundable deposit of \$75.00 must be received within 10 days of signed agreement to maintain reservation. If deposit is not received within 10 days of signed agreement, requested date will not be held and farm appearance will be cancelled.
- Mail checks payable to: Carriage Shack Farm, 5 Dan Hill Rd, Londonderry, NH 03053. For Credit Card payment call (603) 716-0629.
- Once deposit has been processed, confirmation will be sent by email to primary contact. Invoices may be mailed or emailed by request.
- Farm truck and trailer must be able to park within 50 feet of designated set-up area. Set-up and parking area should be reasonably level.
- **Total balance due is expected by the day of the event and prior to set-up or services will not be rendered.**
- Under no circumstance shall farm staff set-up without full payment in-hand. A single payment by cash, check or credit card shall be accepted.
- A 48-hour notice is required if cancellation is necessary. Reservation deposit will not be refunded.
- Schools & other youth organizations are responsible for providing appropriate supervision of the students/children under its charge. Students/children cannot be left unattended at any time in/near pen area. Organization accepts responsibility for the behavior of the students/children under its charge.
- Safety of the animals and the people visiting the animal pens is of the utmost importance. Visitors are expected to follow the direction of farm staff. Unruly, unsafe and/or inappropriate behavior of any kind including aggression towards the animals, or offensive language will not be tolerated in or around animal pens. Posted rules shall be strictly observed. No Smoking or alcoholic beverages will be allowed. Farm staff reserves the right to restrict access to animals or ask individuals to leave pen area if direction from staff is being ignored or displayed behavior is deemed unsafe, inappropriate, and/or alcohol is suspected. The organization is expected to support Carriage Shack Farm in matters where safety is of concern.
- The organization expressly agrees to defend, indemnify, and hold harmless Carriage Shack Farm from and against any and all claims for loss or damage to personal property, or injury to, or death of person or persons arising in any manner out of use of products and services furnished under this agreement.
