- Artist will complete final design in such a manner to allow for clean-up and break-down of equipment by end of allotted session time.

**FEES & SERVICES**

A non-refundable booking fee of \$35 is required to secure date & time for artist services. Hourly rate includes; Artist's labor, cost of all product used, equipment, set-up/break-down.

Travel Fee: \$1.50 per mile calculated one way from artists' home base to party /event address.

**FACE PAINTING MATERIALS**

Only high-quality professional water-based face paints compliant with FDA cosmetic regulations are used. These paints are hypoallergenic and include anti-bacterial properties which are specifically for use on the face and skin. Paint can easily be removed using mild soap and water or baby wipes. Rinse water is changed regularly during painting sessions and only clean brushes/sponges are used on every face.

**TERMS AND CONDITIONS:**

- 1) Host must submit within 5 business days of request to reserve date and time for artist services a signed service agreement and non-refundable booking fee of \$35. Date and time will not be reserved until booking fee and signed agreement has been received and processed.
- 2) Mail checks payable to: Face Painting by Chy, 5 Dan Hill Rd, Londonderry, NH 03053. For Credit Card payment call (603) 716-0629.
- 3) Once booking fee has been processed confirmation will be sent by email to party host.
- 4) Total balance due is expected on or before day of party and prior to set-up or services will not be rendered.**
- 5) If cancellation is necessary; a 48-hour notice is requested. If cancelled booking fee will not be refunded.
- 6) Artist services are booked for a specific window of time. Host is responsible for party preparations that allows for the Artist to begin painting at the start of the reserved time. Time will not be extended due to a late start where host is not prepared for the Artist's arrival.
- 7) Artist is entitled to periodic 15-minute breaks as needed during sessions exceeding 2 hours regardless the number persons waiting in turn.
- 8) Without prejudice the Artist has the right to refuse their services to anyone.**
- 9) The Artist will not paint anyone who is obviously unwell, including but not limited to; having a runny nose, temperature, or rash; or any other visible skin complaint such as eczema, chicken pox, acne, cold sore, or open wound; or signs of eye infection, etc.
- 10) If the person to be painted is believed to have sensitive skin, a skin patch test can be carried out. It is the person, parent or guardian's responsibility to inform the Artist of this in advance. The Artist cannot be held liable for allergic reactions to the paint.
- 11) Children must be under constant adult supervision whilst being painted or waiting for their turn.
- 12) Children who are not wanting to be painted against their wishes will not be pushed to have their faces done or design completed; this may result in stopping painting before the final result or if a child becomes uncomfortable or changes their mind. Parents should not force their child to be painted if they are uneasy or unwilling – face painting should be fun for both the child and parent.
- 13) Under manufacturer guidelines; face paint is not recommended for use on the faces of children who are age 3 or under, however a small design can be painted on the back of a hand or arm instead of the child's face by discretions of the parent/guardian and Artist.
- 14) When hiring an Artist for a children's party, it is important parents/guardians are made aware in advance that a face painter will be on site, especially when parents/guardians are unlikely to remain present. It is the responsibility of the host to ensure parents/guardians have been informed so that permission for face painting their children is given. Host accepts all responsibility for the children under their charge.
- 15) The person or persons responsible for contracting the Artist's services under this agreement expressly agrees to defend, indemnify, and hold harmless Face Painting by Chy and affiliates from and against any and all claims for loss or damage to personal property, or injury to, or death of person or persons arising in any manner out of use of products or services rendered under this service agreement.
