**TERMS AND CONDITIONS OF FARM VISIT**

- o The date and time requested is not reserved until a signed reservation agreement is received. A non-refundable deposit of \$50.00 must be received within 10 days of signed agreement to maintain reservation. If deposit is not received within 10 days of signed agreement, requested date and/or rain date will not be held and reservation will be cancelled.
- o Mail checks payable to: Carriage Shack Farm, 5 Dan Hill Rd, Londonderry, NH 03053. For Credit Card payment call (603) 716-0629.
- o Once payment has been processed, confirmation of reserved date and time will be sent by email to primary contact.
- o A 48-hour notice is required if group will be larger than originally estimated to ensure package services are available for group visit.
- o Payment of entire balance due is expected on the day of group visit. Total group count and balance due will be calculated the day of group visit.
- o A single payment of entire balance due by cash, check or credit card is expected. Individual payments from group members will not be accepted.
- o Farm is open rain or shine. Management reserves the right to reschedule reservation to a future date in the event of severe weather conditions.
- o A 10-day notice is required if group wishes to reschedule. Initial deposit is not refunded if cancellation is necessary.
- o Group will be admitted in whole upon arrival. Individual arrivals will pay standard admission fees not including the amenities of the group package.
- o School groups with morning and afternoon sessions may schedule more than one arrival time per date requested.
- o Group organizer(s) are responsible for providing the appropriate supervision for the children in their group, and managing their group's behavior.
- o Safety of the animals and all patrons visiting the farm is of the utmost importance. Management reserves the right to restrict access to animals, animal pens and other areas of the farm, as well as, restrict or replace offered activities where safety of animals or persons may be of concern.
- o Unruly, unsafe and/or inappropriate behavior of any kind including offensive language will not be tolerated. No Smoking or alcoholic beverages allowed on the premises. Management reserves the right to ask individuals or entire groups to leave if behavior is deemed unsafe, inappropriate, and/or alcohol is suspected. No refund of any kind if individuals or entire groups are asked to leave under any circumstance.
