## **TERMS AND CONDITIONS:**

- 1) Scheduling is first come first serve, desired date will not be held in waiting for more than 5 days.
- 2) To secure a date a 30% deposit of subtotal and signed agreement form must be submitted within 5 business days of request to reserve a date.
- Once deposit has been processed, confirmation will be sent by email to primary contact.

  \*Invoice available by request.
- 4) Mileage Fee: \$1.50 per mile calculated one-way from farm address to event location address.
- 5) Total balance due is expected on or before day of event. Balance paid on day of event is expected upon arrival and prior to set-up. Under no circumstance will farm staff begin set-up without full payment in-hand. Services will not be rendered without payment.
- 6) A single payment by cash, check or credit card will be accepted in paying final balance.
- 7) **Cancellation Fee \$150 A** 48-hour notice is required If cancellation is necessary. Deposit will be returned less \$150 within 15 days of notice to cancel reservation.
- 8) Farm truck and trailer must be able to park within 50 feet of designated set-up area.
- 9) Both parking and set-up area must be reasonably level.
- No unauthorized personnel or visitors will be allowed in/on farm vehicles or equipment.
- No unauthorized personnel or visitors will be allowed in pen area during set-up or break-down.
- 12) Traveling farm comes equipped with hay bales for seating and décor, pop-up shelter for shade or rain, hand sanitizer, animal pen(s), and an assortment of clean, friendly farm animals.
- 13) Animal assortments listed may vary by season and is subject to change without notice.
- Indoor set-up: for an additional fee floor covering such as heavy canvas, rubber mats, etc. can be placed under pen area(s) as a barrier against animal foot-traffic. Though intended to provide some protection, it is not a guarantee against potential damage. Carriage Shack Farm provides no warranty against damage from animal foot-traffic to indoor flooring surfaces such as but not limited to; wood gymnasium floors, vinyl plank or tile, laminate, concrete, ceramic, etc.
- 15) Schools & other youth organizations are responsible for providing appropriate supervision of the students/children under its charge. - Animals may be pulled aside by discretion of farm staff, as needed, from time to time during events exceeding 2 or more hours for watering, and other forms of care, etc.
